A STATEMENT FROM PALAIS FHLEAMAINN

Residents and civilians of Mabruenia,

Some developments happened from May 2nd to May 3rd. A peace negotiation, named Operation Riposte was mediated between Gunaka, Hokoria, Novafides, and our nation. Initially, the terms were as follows:

- Both sides retract bad statements about each other
- Defamatory statements regarding out Queen Consort are to be revoked.
- Both sides apologize for escalating the conflict.

Both sides agreed to this. However, Chancellor Hopkinson, the day before negotiations would take place, would resign from their post, and remain as Speaker of the House. Chancellor Hopkinson would note that they failed in their promises to the nation, and as such, they felt like they couldn't stay as chancellor. Deputy Chancellor Garland would take their place, being next in line, with him naming Samuel as Deputy Chancellor. On May 2nd, former Chancellor Hopkinson would remove Alexandra Irikladis and her Majesty Amara Fleming from Novafides, and dissolve the Irikladian Front, for "safe-guarding" reasons.


When asked why via Chancellor Garland, they would notably tell him that "After doing psychological evaluations during the negotiations, and assessing my experiences with Desslok, I felt like

it was best to remove Alexandra.”. When Garland questioned Hopkinson about it, they ordered him to stop, under threat of removal. Deputy Chancellor Samuel would ask them why they did this as well, and they would inform him that they did it in the interests of Novafides. The same day, San Donia would declare the treaty we had with them null and void, as a result of Chancellor Garland being angry for being punished by the king of San Donia, due to what we assume was Willow of Hokoria telling him that Garland was trying to dox her. San Donia would come to Her Majesty with several demands:

- Remove Garland from office
- Apologize for sending a legal cease and desist to JDPrune
- An apology from the government regarding Garland’s actions
- And a public acknowledgement of guilt regarding every previous allegation related to our Queen Consort made by San Donia.

Mabruenia would deny the terms, and in turn, declare war on San Donia, as a result of the demands. In response, Tresca and Turisa would declare war on Mabruenia as well, intending to destroy the kingdom.

The Mabruenian Kingdom hereby condemns Novafides, San Donia, Tresca, and Turisa. Former Chancellor Hopkinson is charged with treason against the state, for helping our enemies and their citizenship, titles and honors are revoked hencefort. The treaty between Novafides and Mabruenia, splitting Lillia along an east-west axis is now null and avoid, and we now proclaim as Prince Imperial His Majesty the Czar, Oliwiér, Minister of Education and Culture and rightful monarch of all Lillia.
